



The Isla Vista Federation is a coalition and I don't think that Bill Wallace has helped of I.V. interest groups which meets 6-7 times a year to discuss issues before the community. Actually, the IVCC was able to maintain an office and a telephone until about two years ago from the profits it earned from operation of the post office contract station now operated by Rexall Drugs. Although no official charges have ever been filed against me, I did agree to take an "administrative" leave during the investigation. 

HALLOWEEN FAIRLY COOL

Well. Halloween came and went, and the town survived.

Even though the police reported that as many as 40,000 people attended this year's street bash, most local residents felt that there were far fewer people this year than last when 30,000 were reported to have raged through I.V.'s streets.

The police made their presence felt by giving over 1,000 tickets ("most were for alcohol related offenses," they said), and carting 215 people off to jail. The arrests more than doubled last year's tally.

A slow rain for most of the afternoon and early evening probably both cut the numbers of the participants and dampened the audacity of the people who did show up.

The portable toilets and the Red Alert volunteers both seemed to be successful innovations for this year's event. And, the 100 or so volunteer clean-up crew on Sunday had the town looking better than usual by mid-afternoon.





LOCAL RULE

Presently, Isla Vista and Goleta share 1 of 5 County Supervisors. Decisions affecting us (such as the 'open container law') are dominated by Supervisors from distant locales such as Lompoc, Santa Maria, and Montecito. Cityhood replaces them with a city council, all elected locally. Meausre Q was written by an Isla Vistan, and gives I.V. 2 of the 6 council seats. All of us are fairly represented, and together gain control over vital regional decisions.

BETTER SERVICES

Measure Q brings increased revenues from the State for environmental protection, emergency services, road repair, health and safety, the homeless disabled, parks, etc. With high quality services, and no increased taxes, our new city has a projected annual surplus of over \$2 million. In contrast, county funding and services are deteriorating in the wake of Proposition 4.

YOUR DECISION

YES on Q for self-rule and better vital services, or no and suffer with the county. These are the only options. Don't be misled by fantasies of a 1/2 square mile ghetto, where the average resident departs 4 months each year, stays less than 3 years and has little time for involvement, with no industry and nothing to tax by a low-income populace. Wasting your chance for altyhood by speculating on an imaginary alternative is throwing your vote away.

CITYHOOD IS THE WISE CHOICE

Measure Q is supported by a diversity of citizens, including UCSB students, faculty, and the administration, environmentalists, the Fire Marshall, local businesses, and our County Supervisor. It is opposed by a landlord with 56 apartments in I.V. and Goleta (who fears rent control) and a few I.V. politicians protecting their income and influence. Measure Q conflicts with their special interests while bringing better services and self-rule to our community.

MEASURE Q: NO... and YES

If you are interested in a city government which will reflect the community in which you live, if you want a city government which will be both easy and inexpensive to get involved with, if you feel that the history of interaction between Isla Vista and Goleta community activists doesn't warrant sufficient trust to give up the hope for a better cityhood option (such as an independent City of Isla Vista, or even a City of Goleta West of Patterson that would have 40% I.V. voters), and if you feel that RENT CONTROL is a bottom line requirement of any city government for Isla Vista, then you will want to vote NO on Q.

On the other hand, if you are mostly concerned about increasing services to this hard-pressed community, but you don't want to have to assume personal responsibility for the city which will be created, then YES on Q is probably how you want to vote.

While it shouldn't be the only reason that you vote one way or another, before you cast your ballot you should reconcile with your own thoughts why Isla Vista residents have rejected a combined city with Goleta ten times in local government options plebiscites over the past fifteen years.

Finally, we encourage you to vote as if you were going to be living here for the next decade, because even if you personally aren't going to be here that long, someone who will be facing almost exactly the same living conditions will be here in your place. Both you and the future generations of Isla Vistan and Goleta residents deserve your thoughtful consideration on this question.

I.V. Sanitary Board: WEXLER & BEARMAN

The "Sewergate" scandal in which incumbent candidate Richard Smith was thoroughly involved, and street cleaning in both Isla Vista and the most densely populated areas of Goleta are the biggest issues in this campaign for two seats on the Isla Vista Sanitary District — in which 60% of the voters live in Western Goleta, and only 40% in LV.

We commend Director Dave Bearman for his persistence in exposing the manipulations of directors Smith, David Lewis, and Ken Hendrickson following the resignation of a former director last Summer. Scott "Seriously" Wexler, director of the Goleta Seniors Center, and the candidate with the most imaginative posters in the campaign, also wants to restore democratic government to the San. District — where the cronysm has gotten so thick that the general manager has a stack of re-election literature for Smith on his desk at the District offices!

Both Bearman and Wexler support a people-powered street cleaning program for I.V. and relevant parts of Western Goleta that is both more efficient and cost-effective than the District's current machine cleaning program.

As we have pointed out on several previous occasions, Bearman owns a 2% share of this newspaper.

Goleta Water Board: CRAWFORD, MYLOD, & FULKS ... and Mike Boyd.

We have endorsed the Citizens for Goleta Valley's conservationist slate of Katie Crawford, Pat Mylod, and Gordon Fulks for the three open seats on the Goleta Water Board. However, we also recommend Mike Boyd as a protest for the lack of representation of Isla Vistans in Goleta Valley environmental politics.

ENDORSEMENTS

IN OUR TWO PREVIOUS ISSUES, WE MADE SEVERAL ENDORSEMENTS AND EXPLAINED OUR REASONS WHY. WHAT FOLLOWS IS A SUMMARY OF THOSE ENDORSEMENTS AND SHORTENED VERSIONS OF OUR EXPLANATIONS.

Measure T: IT'S UP TO YOU

This will permit approximately 250 single family residences to be built throughout the every vacant lot left in that section of town. Two of these 250 homes will go to people who have been on the request list since before the water hook-up moratorium was passed by area voters in 1972; more than half will go to people who have signed up during the past five years.

If passed, Measure T will also provide water for Isla Vista's park lands, most of which were purchased after the moratorium and therefore lack water,

Finally, Measure T will likely give the St. Anthanasius (Evangelical Orthodox) Church sufficient water to build a temple in Isla Vista's "Perfect Park."

The water for this project will come from a new dam, not from drilling into the already overdrafted central water basin.

Measure R: "GOLETA VALLEY"

We think that "Goleta Valley" is preferable to "Goleta" primarily because it would acknowledge a change in the status quo for both Isla Vista and Goleta. And, traditionally, "Goleta Valley" has referred to both communities. Actually, if there is to be a city combining I.V. and Goleta, we would have preferred "Dos Pueblos" as its name.


Measure S: DISTRICTS

Regardless of how you vote on the creation of this proposed "city," vote to establish a "districts" form of city council. At-large elections would mean very expensive candidate campaigns, probably \$30-50,000 campaigns. This would put a seat out of the reach of most Isla Vistans, especially students, and lead to coalitions with Goletans who would unlikely support a "regular" Isla Vista activist as part of "their" state.

With districts, I.V. voters (not Goleta power brokers) will be sending at least one representative to the new city hall.

Measure W: NO!

Certainly it is appropriate for citizens to decide to spend more than the limits established by the State Gann Initiative. However, in this case County taxpayers would be better served if the County were to back away from its spending limit by encouraging its unincorporated areas to become part of cities (either by establishing new ones or annexing to existing ones). About 50% of this County's population live outside of cities; in Ventura County, only 14% do.



Third in a Series About Your ISLA VISTA RECREATION & PARK DISTRICT

MORE THAN JUST PARKS...

QUESTION: Why is the Park District's Motto "More than Just Parks"?

ANSWER: The Park District is owned and operated solely by the voters of Isla Vista. It is the only empowered local government that the community has. As such, persons elected to the Park Board have generally recognized that we have to act to defend the electorate's interests in the areas that go beyond parks.

QUESTION: Give me an example.

ANSWER: In 1975, Isla Vista voters approved a \$1.15 million park bond. Approximately 25 acres were purchased with these monies to preserve as open space and to protect against development. Land was bought even though maintenance funds were lean, because it was felt that public purchase of scarce open space was

QUESTION: I've noticed that there is a lot of activity recently in the Park District's open space. Why?

sound environmental planning.

ANSWER: Over the years, the public has requested that these open space lands receive a higher level of care. As the largest landowner in I.V., the Park District's board of directors has decided to set a more positive example for property upkeep, although it costs a little more (this year's "benefit assessment" was \$30 per household). The current Board feels that these improvements are worth it.

QUESTION: Are you planning another Park Bond? ANSWER: We plan to put something before the voters in April.

Right now a committee is conducting fact-finding before making a recommendation to the Board. So far we are planning on using the bond to finance buving more parkland and developing a recreational facility. Everyone is encouraged to come to the public hearing Saturday, November 14 at 1 pm in Anisq'Oyo Park to make suggestions and give input to the Board along with hearing the Committee's recommendations.

QUESTION: What About Recreation?

ANSWER: The District sponsors the annual Isla Vista Spring and Fall Festivals. We have a pottery center where instruction is available. We operate several acres of garden plots. We also have meeting space for rent, and rent out the Red Barn for band rehersals, theater, parties and dances. We rent the stage in Anisa'Oyo Park for \$20.

QUESTION: Why does the Park Board take stands on social Issues like Apratheid and Central America?

ANSWER: The Board can take a position on any issue it desires. Most of the folks elected to the Board over the years believe they should speak out on larger matters. It is rare for the District to spend money on such matters beyond directing staff to send a letter expressing the Board's position. In the case of Apartheid, the Board asked the County not to invest any of the Park District's funds in South Africa.

QUESTION: I heard that the Park District was spending money in order to defeat Measure Q, the plan to make one city out of Isla Vista and Goleta.

ANSWER: No District funds have been authorized or spent on this. effort. The Board has taken a very strong position against Measure Q. Most Board members and some employees have been working against Measure Q, BUT ALL OF THESE EFFORTS ARE ON THEIR OWN TIME.

QUESTION: Does the Park District give money to other agencies?

ANSWER: The District is considering renewing some financial support for the Isla Vista Youth Project's recreational programs. In the past, we have also donated small sums to agencies like the Rape Crisis Center. We'd like to do more, but our budget is dedicated to parks and recreational services.

Towards A Better Halloween Dear Freen.

First of all, congratulations to those who helped in cleaning up after the Isla Vista melee — 95 of us in all. We worked for many hours to pick up after the mess made by last Saturdays' partiers both from our community and many, many not of our community. My appreciation, also, to those who organized the cleanup - they did a fine job.

Second. I must register my total dissatisfaction with the fact that cleanup was left to the few in the community who cared enough to volunteer. The kind of mess made by tens of thousands of revelers, many of them sloppily drunk, seems to me to warrant much more than a volunteer brigade. When I look at the stark contrast between the money spent on riot-gear rigged police (150 or so of them) and other forms of crowd control and the lack of funds relegated for the protection of the physical town itself against this invasion, I feel very frustrated. I wonder how many of the over 200 who were arrested that night were arrested for littering? We really could have 'cleaned up' on that one!

Perhaps for future events, the out-of-towners who flock here could be charged admission, or a parking fee, so that L.V. could have a paid clean-up crew come in afterward. And perhaps the Greek organizations could chip in some money, since hardly any of them saw fit to clean up after themselves and their sisters and brothers they invited from far and wide. Then, too, the merchants who sell food and beverages in L.V. could help to provide money for cleanup—they make a huge profit on a weekend like this and it would not seem amiss that they contribute a little of their windfall earnings.

Dear Editor,

Measure T is bad for Isla Vista. It offers benefits, but they are dwarfed by the damage this proposal would inflict on our community.

Measure T promises water to some who need and deserve it. Our parks could be improved with the additional supply. An I.V. church hopes Measure T will allow them to expand. One might also sympathize with families who Measure T will enable to build a home on land they bought up to 14 years ago. Clearly, some benefits would accrue if the measure passes.

Other consequences of Measure T are ruinous. Most vacant lots in I.V. would be instantly developed if they had water. Measure T gives water to most of them. Any serenity, wildlife, quiet spots, or ecological balance remaining in Isla Vista would be overwhelmed by the additional cars, pollution, and congestion that accompany rapid uncontrolled growth. Real estate speculators living elsewhere reap the profits of development; we suffer the environmental degradation.

Measure T might as well change the name of I.V. to L.A. As the open land vanishes and crowding worsens, our quality of life will deteriorate. Isla Vista deserves better. We are responsible for protecting this scenic, sensitive ecosystem from unrestrained plunder.

To preserve I.V., vote NO on T.


